<u>First Efficiency Bar Examination for Grade III Nursing Officers – 2013</u>

It is notified hereby that the Efficiency Bar Examination to be passed by Grade III

Nursing Officers before reaching the fourth salary point of the approved scale will be held on 18-08-2013 in

Sinhala, Tamil and English media. The venue and the timetable will be sent along with the admission card.

Only those Nursing Officers who sit the examination for the first time and those who could not get through

the examination at a previous examination are permitted to sit this examination.

02. **Qualifications**

The Nursing Officers categorized under Grade III in the Nurses service minute published in the Gazette No

1684/18 of 14-12-2010 can apply for the Examination.

03. Applications

Applications for the Examination should be forwarded on forms prepared by themselves as per format

appended to this letter to the Director (Examinations), Suwasiripaya, No 385, Ven Baddegama

Wimalawansa Thero. Mawatha, Colombo 10.through the relevant Head of Institutions under registered cover

to be received on or before 30-06-2013. The Head of Institution shall certify the contents of every application.

Every application shall accompany a self addressed envelope (may write the official or private address) of

9" x 4", affixed with stamps to the value of Rs. 30.00 and those Applications received late or incorrect will

be rejected.

Note - The nursing officers those who sat for the examination at least once under the

previous Nursing Minute, need not submit applications as per this circular.

The application should be prepared using an A4 paper based on the specimen form of the application

so as to recommended from 01 to 04 on the first front page and from 05 to 10 on the second page.

Application which do not conform to above will be rejected any information.

04. Examination fees:-

(i) The applicants for the first time will be exempted from exam fees. The others who had applied for but not sat the Examination shall affix stamps to the value of Rs. 25/= per subject in the application and cancel them by placing their signatures and the date. Under no circumstance the fees once paid will be refunded or changed for another Examination.

05. Admission to the Examination:-

- **05.1** Admission cards will be issued for properly perfected applications. The applicants should perfect the admission card and hand them over to the supervisor at the Examination. Otherwise they will not be allowed to sit the Examination.
- **05.2** The applicants shall establish their identity to the supervisor within the Examination center by producing one of the following.
 - (a) National Identity Card
 - (b) Departmental Identity Card
 - (c) Driving License
 - (d) Passport

06. Scheme of the Examination:

This Efficiency Bar examination consists of two parts viz: Establishment Code and the Financial Regulations. Each part will receive 100 Marks . Applicants shall scoure minimum of 40% marks to have a pass in the Examination . They can complete the examination at once or several occasions.
