1. Chairman, Cabinet Appointed Procurement Committee on behalf of Ministry of Health invites sealed bids from eligible and qualified bidders for the Supply, Installation & commissioning of 137 Nos. Anaesthetic Machines at Government Hospitals.
2. Bidding will be conducted through the International Competitive Bidding (ICB) procedure.
3. The interested bidders may obtain further information from Senior Assistant Secretary (Procurement) at the Ministry of the Health and inspect the bidding document at the address given below on working days from 9:00 a.m. to 2:00 p.m.
4. A complete set of bidding documents in English language may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee of LKR 3,000.00
5. The bidders also should submit followings
 - i. The Certificate of Business Registration (Certified photocopy).
 - ii. The Certificate/ letter issued by the Principals appointing the bidder as local agents for the particular products.
 - iii. The Certificate of registration issued by the Registrar of Companies under the section 8 of Public Contract Act for offer to be eligible in this procurement (Certified photocopy) when purchasing the Bidding document.
6. The bid must be delivered to the address below on or before 28.12.2015 at 10.00 a.m. through parcel post or courier service. OR otherwise completed bids can be deposited in the Tender Box kept in the office of the Assistant Secretary (Procurement) of Ministry of Health, Nutrition & Indigenous Medicine. This bid must be submitted in one original and one copy and must accompany a bid security issued by a bank operating in Sri Lanka OR directly from a bank in Sri Lanka approved by the Central Bank of Sri Lanka, amounting for LKR 10,960,000.00. Bids will be opened at the address given below immediately thereafter the time mentioned above, in the presence of Bidder's representatives.
7. The bid shall be valid for 180 days from the date fixed for receiving of bids or any extended period and it shall remain binding upon us and may be accepted at any time before the expiration of the period.
