SUPPLY AND INSTALLATION OF DIAGNOSTIC X-RAY MACHINES

1. Chairman, Standing Cabinet Appointed Procurement Committee on behalf of Ministry of Health Nutrition and Indigenous medicine now invites sealed bids from eligible and qualified bidders for the Supply and Installation of Diagnostic X-ray Units at Government Hospitals in Sri Lanka.
2. Bidding will be conducted through International Competitive Bidding (ICB) Procedure.
3. The interested bidders may obtain further information from the Senior Assistant Secretary (Procurement) at the Ministry of Health, Nutrition and Indigenous Medicine and may inspect the bidding document at the address given below on working days from 9.00 am to 2.00 pm.
4. A complete set of bidding documents in English language may be purchased by interested bidders on the submission of the following to the address stated below and upon payment of a non-refundable fee of LKR 3,000.00. The method of payment will be in cash.
 - a) A written application addressed to the Senior Assistant Secretary (Procurement), Ministry of Health, Nutrition and Indigenous Medicine.
 - b) Certificate of Business Registration (Certified Copy)
 - c) A certificate / Letter issued by the principal appointing your company as the local agent for the product.
 - d) Upon-payment of the non-refundable fee stated above in cash to Accountant, Ministry of Health, Nutrition and Indigenous Medicine.
 - e) Upon production of the certificate registration issued by the registrar of companies under the para 8 of public contract act for each offer to be eligible in this procurement. (Certified copy).
5. The sealed bids must be delivered to the address stated below on or before 28.12.2015 at 10.00 am through parcel post or courier service. OR otherwise completed bids can be deposited in the tender box kept in the office of Assistant Secretary (Procurement) of Ministry of Health, Nutrition and Indigenous Medicine. The bids must be submitted in one original and one copy. Bids will be opened at the address given below immediately thereafter at the time mentioned above, in the presence of Bidder's representatives, who intend to attend.

6. The bid shall be valid for 180 days from the date fixed for receiving of bids or any extended period accepted at any time before the expiration of the period.
7. All bids shall be accompanied by a Bid Security which shall be;
 - a. in the form included in Section IV – Bidding Forms
 - b. in favor of Secretary, Ministry of Health, Nutrition and Indigenous Medicine.
 - c. an amount of LKR 4,460,000.00
 - d. Valid up to 23.07.2016
 - e. Issued by one of the agencies indicated in the clause 21.2 (b) of Section I – ‘Instruction to Bidders’ of the Bidding Document.
