3. Any seniority violations or errors with regard to the interim order intimated through the appeals process will be rectified by the appeals board on Annual Transfers 2016.
4. Interim orders of Medical Officers (even those who do not appeal) are liable to change upon correction of any seniority violations or errors with regard to the interim orders.

9. With the date of publishing this interim list, Annual transfer orders given in Annual Transfer final list – 2012,2013,2014,2015 and other Transfer orders will not be cancelled. They should release immediately.

10. In case of not enough preferences being selected in the appeals application the transfer board would assign a station at the discretion of the board and be marked as NEP (Not enough preferences). Seniority date corrected for no pay leave will be marked as NPL.
