4. Bidding will be conducted through the International Competitive Bidding (ICB) procedure.

A complete set of Bidding Documents in English language may be purchased by interested bidders from the Additional Secretary (Procurement) of the Ministry of Health, Nutrition & Indigenous Medicine, 6th Floor, No. 464, T.B. Jaya Mawatha, Colombo 10, Sri Lanka on working days **from 21.08.2017 to 02.10.2017 at 09:00 hrs. to 14:00 hrs.** on the submission of a written request to the above address upon payment of a non-refundable fee of **Rs.35,000.00** in cash to the Secretary, Ministry of Health, Nutrition & Indigenous Medicine.

Sealed Bids in duplicate and Original separately kept in one envelope must be sent by registered post to the Chairman Ministry Procurement Committee or deposited in the Tender Box at the above address **on or before 10:00 hrs. on 03.10.2017**. Late bids will be rejected. Bids will be opened in the presence of the bidders or authorized representatives of the bidders at the same address immediately after the closing of bids.
8. **Pre-Bid Meetings will be held on 12.09.2017 at 10:30 hrs.** at the Office of the Epilepsy Unit Project, 8th Floor, National Hospital of Sri Lanka ,Colombo-08, Sri Lanka.

All Bids must be accompanied by a "Bid Security" issued by a Commercial Bank operated in Sri Lanka , approved by the Central Bank of Sri Lanka or a bank based in another country but the guarantee "confirmed" by a bank operating in Sri Lanka approved by the Central Bank of Sri Lanka Amounting to US Dollars 26,000.00. Details are in the bidding document.
10. Procurement Committee has the right to reject all the bids or part of the bids.
