1. Chairman, Ministry Procurement Committee on behalf of the Secretary of the Ministry of Health, Nutrition & Indigenous Medicine invites sealed bids from eligible and qualified bidders for supply and delivery of undermentioned unregistered brand new vehicles.

2. Bidding will be conducted through National Competitive Bidding Procedure.

3. Following conditions apply will be applied for supply & delivery of Motor Car

- Bid Documents will be issued only to the vehicle agents who are franchise holders of world renowned vehicle brands available in Sri Lanka, financial institutions registered under the Central Bank of Sri Lanka, and car rental services (i.e. Rent a Car Companies) with at least 10 vehicles in fleet. Vehicles imported under any concessionary permit scheme of the Government cannot be leased under this scheme. No Bids will be accepted from foreign
- The Lessor should bear all routine maintenance costs, including expenses on accident repairs as well as insurance and other related fees. If repairs and maintenance works take more than 24 hours, or in a shorter period as per the requirement of the lessee, the lessor is required to provide a replacement vehicle of similar type and condition.
- All terms and conditions of this procurement notice are governed by the National Budget Circular No. 1/2016 dated 17. 03. 2016 and No. 1/2016 (i) dated 19. 09. 2016, issued by the National Budget Department.

4. Following conditions apply will be applied for supply & Delivery of three wheeler and motor cycles.

- Bid Documents will be issued only to the manufacturers or sole nominated representative/ accredited agent of manufacturers of the vehicles offered for the Sri Lankan market, who are eligible to participate in this procurement. No bid will be accepted from foreign principals who do not have sole nominated representative/accredited agents in Sri Lanka.

A complete set of bidding documents in English language may be purchased by interested bidders from the Senior Assistant Secretary (Procurement) of the Ministry of Health, Nutrition & Indigenous Medicine, at the address given below, on working days from 9.00 am to 2.00 pm up to 28.09. 2017 on submission of a written request, original business registration certificate (with a certified copy), registration certificate under para 8 of the public contract act (with a certified copy) and upon payment of a non-refundable fee as above-mentioned.

7. Sealed bids in duplicate must be delivered to the address below on or before 10.00 am up to on 29.09.2017. All bids must be accompany a bid security issued by a commercial bank operated in Sri Lanka approved by the Central Bank, or a reputed insurance company operates in Sri Lanka approved by Board of Insurance Sri Lanka, amounting the corresponding value above-mentioned, valid for 119 days from closing of bid. Bids will be opened, in the presence of the bidder's authorized representatives at the address given below immediately after the time mentioned above.
