The cost estimate is LKR 714 million and contract period is 12 months.
2. Bidding will be conducted through National Competitive Bidding (NCB) method.

A Complete set of bidding documents in English language may be purchased by interested bidders on the submission of a written request to the Senior Assistant Secretary (Procurement) at the address below during working days between **09:30 a.m.** and **02:30 p.m.** up to **13.06.2018** together with the PCA3 certificate for this tender issued by the Registrar of Companies under the para 08 of Public Contract Act and upon payment of a non-refundable fee of **LKR 60,000.00** to the shroff of Ministry of Health, Nutrition and Indigenous Medicine. The method of payment will be cash payment.
4. Bid shall be valid for **119 days** from deadline of the submission of the bid.
5. All bids must accompany a bid security issued by a commercial bank in Sri Lanka as per the table below for a validity period of **147 days**.
