2. Bidding will be conducted through National Competitive Bidding (NCB).

Bid document will be issued only to the manufactures or sole nominated representative/ accredited agents of manufacturers of the vehicles or experienced/ reputed vehicle importers to the Sri Lankan market, who are eligible to participate in this procurement. No bid will be accepted from foreign principals who do not have sole nominated representative/accredited agents in Sri Lanka.

A complete set of bidding documents in English language may be purchased by interested bidders from the Additional Secretary (Procurement), on working days from **2017.07.04 to 2017.07.18 between 9.30 a.m. to 2.00 p.m.** on the submission of a written request with a certified copy of Business Registration Certificate, Registration Certificate under para 08 of Pubic Contract Act (with a Certified Copy) and upon payment of a non-refundable fee as per the above schedule.

Duly filled bidding document marked "Original" and "Duplicate" on the relevant two sealed envelopes and enclosed both in one sealed envelope marked "Bid for the procurement of (Name of the Procurement)" on the top left hand corner of the separate envelope should either be sent by Registered post or deposited in the tender box kept at the address, Procurement Division of the Ministry of Health, Nutrition and Indigenous Medicine (New Building), 06th floor, No.464, T.B. Jayah Mawatha, Colombo 10 at or before **10.00 a.m. on 2017.07.19.**

All bids must accompany a bid security valid for 119 days from the closing date of bid issued by a commercial bank operated in Sri Lanka approved by Central Bank, or a reputed insurance company operates in Sri Lanka approved by Board of Insurance Sri Lanka, amounting as per the schedule.valid for 119 days from the closing date of bid.
7. Late bids will be rejected. Bids will be opened, in the presence of the bidder's authorized representative at the address given below immediately after the time mentioned above.
