2. Bidding will be conducted through National Competitive Bidding (NCB).

Bid document will be issued only to the vehicle agents who are franchise holders of world renowned vehicle brands available in Sri Lanka, financial institutions registered under the Central Bank of Sri Lanka and car rental services (i.e. Rent a car Companies) with at least 10 vehicles in fleet. Mileage of these vehicles should be less than 1000 Km at point of hiring.

6. All bids must accompany a bid security valid for 119 days from the closing date of bid issued by a commercial bank operated in Sri Lanka approved by Central Bank, or a reputed insurance company operates in Sri Lanka approved by Board of Insurance Sri Lanka, amounting as per the above schedule
7. Late bids will be rejected. Bids will be opened, in the presence of the bidder's authorized representative at the address given below immediately after the time mentioned above.
