

# INVITATION FOR BIDS

1. The Chairman, Ministry Procurement Committee 'C<sub>1</sub>' invites sealed bids from eligible bidders for Supply & Delivery of 01 No. of Unregistered High roof Van under operational leasing Method to the Nutrition Co- Ordination Division
2. Bidding will be conducted through National Competitive Bidding (NCB).
3. Bid document will be issued only to the vehicle agents who are franchise holders of world renowned vehicle brands available in Sri Lanka, financial institutions registered under the Central Bank of Sri Lanka and car rental services (i.e. Rent a car Companies) with at least 10 vehicles in fleet. Mileage of these vehicles should be less than 1000 Km at point of hiring.
4. A complete set of bidding documents in English language may be purchased by interested bidders from the Additional Secretary (Procurement), on working days from **2017.07.04 to 2017.07.18 between 9.30 a.m. to 2.00 p.m.** on the submission of a written request with a certified copy of Business Registration Certificate, Registration Certificate under para 08 of Public Contract Act (with a Certified Copy) and upon payment of a non-refundable fee of Rs. 3,500.00.

Jayah Mawatha, Colombo 10 at or before **10.00 a.m. on 2017.07.19.**
6. All bids must accompany a bid security issued by a commercial bank operated in Sri Lanka approved by Central Bank, or a reputed insurance company operates in Sri Lanka approved by Board of Insurance Sri Lanka, amounting for Rs. 153,000.00 valid for 119 days from the closing date of bid.
7. Late bids will be rejected. Bids will be opened, in the presence of the bidder's authorized representative at the address given below immediately after the time mentioned above.
