1. The Chairman, Ministry Procurement Committee “C<sub>2</sub>” (MPC) on behalf of Ministry of Health, now invites sealed bids from eligible and qualified bidders Design, Supply, Installation E - Health Network for Public Health Institutes for 02 years Period.
2. Bidding will be conducted through National Competitive Bidding (NCB). Two envelopes system of public procurement method is followed.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and bidder shall be incorporated under companies Act No.7 of 2007 and have been obtained PCA3 Certification as a registered contractor.
4. A complete set of bidding documents in English language may be purchased by interested bidders from the Additional Secretary (Procurement) on working days from **2021.02.17 to 2021.03.02 between 9.30 a.m. to 2.00 p.m.** on the submission of a written request and upon payment of a non-refundable fee of **Rs.12,500.00**. A non refundable bid document fee should be paid to the Taprobane Branch of the Bank of Ceylon to the Credit of Account No. 7040244 of the Director General of Health Services and a copy of the receipt as proof of payment should be submitted with the bid.
5. Bidding documents can be inspected free of charge.
6. The Technical Proposal and Financial Proposal (Bid submission form and price schedule) should be submitted in separate envelopes. Should clearly mark as “Technical proposal” and “Financial proposal” on relevant envelopes (Two envelopes system of public procurement method is followed). Duly filled Technical and Financial Proposals marked “Original” and “Duplicate” on the relevant two sealed envelopes and enclosed both in one sealed envelope marked “Bid for the procurement of (Name of the Procurement)” on the top left hand corner of the separate envelope should either be sent by Registered post or deposited in the tender box kept at the address, Meeting Room, Procurement Division of the Ministry of Health (Medi House Building), 2<sup>nd</sup> floor, No. 26, Sri Sangharaja Mawatha, Colombo 10 at or **before 10.00 a.m. on 2021.03.03**. The late bids will be rejected.
7. All bids must be accompanied by a Bid-Security of Sri Lankan Rupees **665,000.00** taken from a Commercial bank of Sri Lanka, registered under the central bank of Sri Lanka. Bid-Security should valid for 119 days. **Bid Security should be submitted with Technical proposal.**
