6. Bids must be delivered to the address below at or before 10.00 am on 31.01.2023. Late bids will be rejected. The bid shall be valid **119 days** from the date of bid opening **31.01.2023 up to 30.05.2023**
7. All bids must accompany a bid security issued by a commercial bank operated in Sri Lanka approved by Central Bank, **amounting for LKR 14,917,500.00** The validity period of the bid security **shall be 147 days** from the date of bid opening **31.01.2023 up to 27.06.2023.**
