Outreach Facilities in the Central, North Central, Sabaragamuwa and Uva provinces**

1. The Government of the Democratic Socialist Republic of Sri Lanka (GOSL) has applied for a loan from the Asian Development Bank (ADB) for the Health System Enhancement Project (the Project) and intends to apply a portion of proceeds to engage a consulting firm (the Consultant) to assist the Project Management Unit of MOHNIM in implementing civil works for improvements to identified health facilities.
2. The main objective of the Consultant is to assist the PMU in: (a) designing the civil works for improving the existing facilities or new construction as required; (b) carrying out, in the capacity as "Engineer" to the works contracts; (c) the supervision / administration of the civil works contracts as described in the TOR; and (d); monitoring the civil works program under the Project.

5. A consulting firm will be selected in accordance with the procedures set out in the Procurement Regulations for ADB Borrowers by the Asian Development Bank
