2. Bidding will be conducted through National Competitive Bidding (NCB).
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and bidder shall be incorporated under companies Act No.7 of 2007 and have been obtained PCA3 Certification as a registered contractor.

A complete set of bidding documents in English language may be purchased by interested bidders from the Additional Secretary (Procurement) on working days from **2020.06.30 to 2020.07.13 between 9.30 a.m. to 2.00 p.m.** on the submission of a written request and upon payment of a non-refundable fee of **Rs.3,500.00**.

6. The Technical Proposal and Financial Proposal (Bid submission form and price schedule) should be submitted in separate envelopes. Should clearly mark as "Technical proposal" and "Financial proposal" on relevant envelopes (Two envelopes system of public procurement method is followed).
