Implementation of a Networking System for an Electronic Patient Information Management System(ePIMS) at NPTCCD and District Chest Clinics

The Chairperson, Regional Procurement Committee on behalf of National Programme for Tuberculosis Control and Chest Diseases (NPTCCD) under GFATM project now invites Bids from eligible Network Developers for the implementation of a networking system for its Electronic Patient Information Management System (e PIMS) which is a centralized and web-based information system for managing TB patients island wide.

The ePIMS is consisted of:

1. Aggregate and Case Based Electronic Recording and Reporting System
2. Laboratory Investigation Management Module
3. Drug Stock Information Management Module
4. MDR-TB Patient Recording and Reporting System

The necessary network & hardware for the functioning of the ePIMS in District Chest Clinics(DCC) need to be implemented during the year 2021. Bids are called upon from prospective network service providers for the above purpose.

A. Specific Objectives:

1. To establish secure data transmission channels between the NPTCCD central server and district chest clinics
2. To establish the network infrastructure at each DCC.
3. To expedite the full implementation of ePIMS via the Wide Area Network.

Interested Network Implementers should provide information demonstrating that they have required qualifications, resources and experience to perform the above Assignment along with following details;

- a. Name, address of the firm or institute and profile of the employees pertaining to the networking,
- b. i. Details of previous experience in similar network implementations.
ii. Name and address of the clients, organization and descriptions of networks,
- c. Full curriculum vitae including academic qualifications and relevant experience of staff designated to the Assignment,
- d. Technical qualifications, facilities and resources available for successful completion of Assignment with the allocated period of time,
- e. Experience in health sector (Government/ Private) and similar Networks undertaken by the applicant.
- f. Documentary evidence to indicate financial capability and financial soundness of the firm. Please attach last three years audited financial reports.

The BID submitted by the perspective bidders will be reviewed on the basis of the following to prepare a shortlist:

- a. Background of the firm(s): summarizing their facilities, resources and areas of expertise;
- b. General and specific experience of the firm(s),
- c. Summary of similar Assignment undertaken by the firm(s) in Health Sector,
- d. Practical experience in relevant software applications & reporting tools in Health Sector in the region and in resources limited settings,

e. Availability of appropriate knowledge of the firm and skills amongst staff,

f. Demonstration of technical capacity with constructive opinions to complete the Assignment (Please attach constructive opinions to the TOR) and financial capability to handle this Assignment (Please attach last three years audited financial reports), and

g. Working experience and knowledge in Foreign Funding Agencies and Government Ministries will be an advantage.

Short listed prospective bidders will be called upon for the pre bid meeting and will be briefed on the full project and based on the overall developed project proposals has to be handed over by the bidders.
