

- ii) Certified copies of the academic and professional qualifications.



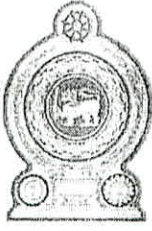
Once an ITEC Programme offered, the recipient is ineligible for any other ITEC Programme.
