



Recommendations for Annual Transfer of Dental Surgeons – 2017 (Stage II)

With reference to my even number letters dated **2016.08.09, 2016.10.28 and 2016.11.18 on the above subject.**

- 1) List of Dental Surgeons recommended for Annual Transfers-2017 is attached herewith. Please consider this as a notice of information calling for appeals. Heads of Institutions are advised not to release these officers till the final transfer order is made.
- 2) These recommendations are based on criteria approved by Public Service Commission in the letter dated 11/07/2007 (Refer Circular Letter)
- 3) The Stations marked with **Temp*** are allocated to Dental Surgeons, at the discretion of transfer board due to not enough preferences in their applications.(NEP)
- 4) Dental Surgeons who wish to get any station marked with Temp can forward an appeal to any such station. Hence Dental Surgeons whose stations marked with Temp should forward an appeal with a list of preferences to get a Permanent Station from the list of vacancies or potentially vacant stations.
- 5) Edited list of Vacant Stations is also attached for consideration. The stations fallen vacant after calling applications for Stage 11 are also included. The officers who wish to apply can forward appeals.
- 6) All appeals against any of these recommendations must be submitted online first and then send hard copy duly signed to the below mentioned address.
- 7) Appeals should be made to the Director General of Health Services **on or before 2016.12.23** and send to reach the following address: Director (Dental Services), Ministry of Health, "Suwasiripaya", 385, Rev.Baddegama Wimalawansa Himi Mawatha, Colombo 10.
- 8) Applications have been considered to transfers only from Dental Surgeons noted for transfers or those who requested to include their name in the eligible list.
- 9) Appeal Board will pay due attention to such appeals and Secretary Health will announce the final approved transfer list soon as possible.
- 10) The officers not noted for transfers but eligible were marked as "regrets" when the requested stations were not available at their seniority positions. **They are free to appeal for vacant or potentially vacant stations, if they wish to get a transfer. Please note that their original preferences will not be taken in to consideration.**
- 11) Appeals will be considered only from those Dental Surgeons who applied for transfers as per DDG/Dental Services Letter No: D/DS/AT/108/2016 dated 2016.08.09
- 12) Transfers were considered to Line Ministry Institutions subject to approved carder given in the Management Services Document No: DMS/0054 dated 2013.12.31
- 13) All Heads of Institutions and consultants of Dental Services should inform any discrepancy of officers allocated to respective stations immediately to 0112-692846
