Annual Transfers of Dental Surgeons-2018

List of Vacancies for the Special Posts/Posts of Dental Surgeons in Specialized Units (Stage I)

01. The List of Vacancies for Special Posts/Posts of Dental Surgeons in specialized units is published as given below.

02. A web based application has been developed for annual transfers stage I and All Dental Surgeons are kindly requested to apply only through online application on the official web site of Ministry of Health (www.health.gov.lk) from 22nd of August 2017 and send the printed copy of the same through proper channel before 06th September 2017.

03. Closing date for stage I is 06th September 2017.

04. Transfers will be assigned in two Stages.

Stage I- Selection for SHO & HO Posts and specialized units for a period of 2 years.

Stage II- All other transfers.

05. All Noted /Eligible Officers those who fulfill the requirements of selection criteria for Special Posts as stated in the previous communication of the letter D/DS/AT/125/2017 dated 2017.07.07 and 2017.08.14 can apply for the given vacancies.

06. SHO/HO posts in specialized units of Dental Services

Dental Surgeons selected should have to serve directly under the supervision of the Consultant of respective units. They are bound to do on call duties. The period of SHO/HO post is 2 years.

- Selection Criteria for HO Posts**– Should be an eligible officer and not have exceeded ten years (10) in the Government Dental Services. Priority will be given for the officers who apply for the first time.

- **Selection Criteria for SHO Posts-** Should have completed HO/SHO post for two year period in the relevant field within eight (08) years. Priority will be given for the officers who apply for the first time.
- **Post of Dental Surgeon in Specialized Units-** Selected Dental Surgeons should have to serve directly under the supervision of the Consultant in Community Dentistry of respective institution/unit. Applicant should have computer literacy in office work. Officers selected will have to engage in proposal writing, programme coordination and visit out station for conducting programmes. For the officers with same seniority, preference will be given will be given in the order of MSc. Community Dentistry ,experience of RDS or in a Public Health Unit/ADC/CDC etc. Period of such post will be 2 years.

07. All special posts will be filled during the stage I transfer schedule. If any post remains vacant at the completion of the stage I those will be filled during the stage II schedule for the period of 2 years according to grade seniority.

08. Officers who are allocated stations in stage I will not be considered for stage II of Annual Transfers.

09. Officers selected for special posts will not be considered for any other posts or transfers during the period of the special post including PGIM training except for MD program. If an applicant appointed to a post and declines to accept it, he/she will not be considered for special post for another two (02) years. Withdrawal of an application will only be permitted before the closing date of applications.

10. Officers already on transfer orders will not be eligible to apply for transfers except for new posts.
