Applications are invited from Post Intern Medical Officers who belongs to below categories as a special privilege.

- Who wish to have a transfer order under N&E transfer List.
- Medical Officer belongs to 2015.II.27 Post Intern Main batch
- Should have **completed minimum period of one year active service** in the Northern & Eastern provinces.

These transfers should be implemented by the Heads of the Institutions only after receiving suitable replacement to the institution or where suitable internal arrangement is possible.

Officers who wish to obtain transfers to institution within North & East provinces may also apply. Such applications will be considered separately according to the service requirements.

Name list of officers eligible for transfer, list of vacancies and specimen application form are attached herewith. These lists were approved by Health Service Committee - Public Service Commission via letter number HSC/APP/MS/I4/I2/2018, dated 12th October 2018.

If an officer has been already selected for any other transfer, application of such officer will not be considered for transfers under this scheme.


