A7. Summary of job:

Consultant community paediatrician is responsible to provide specialized care for children with special needs (development delays, autism spectrum disorders, cerebral palsy, behavioral disorders, learning disorders etc.) in a district/defined area. He /she is the clinical lead of a multi-disciplinary team of special-needs experts (Medical officers, nursing officers, physiotherapists, occupational therapists, special language therapists, social service officers, child protection officers etc.) based in the Secondary Child Development Center (SCDC). The community paediatrician will also provide outpatient and outreach care through Medical Officer of Health (MOH) based Primary Child Development Centers (PCDC).

Take part in educating/ Capacity building of mothers or caretakers of children with special needs is an integral part of care. Expert inputs by the consultant Community Paediatrician in training or empowering mothers in a view to increase the quality of lives.

B4 Tasks/ functions (duty list):

Consultant Community Paediatrician's main scope of work include the following:

1. Provide specialist care for children with special needs
 - Address the needs of children with
 - a. Developmental delay and concerns - assessing, undertaking developmental assessments as appropriate and offering parent support, monitoring and early interventions
 - b. Behavioral illnesses disorders - assessing, offering parental support, offer interventions and referrals to the child psychiatry team for further management
 - c. Language and learning difficulties and disorders
 - d. Cerebral palsy and other physical disabilities
 - e. Neonates at risk of developmental disorders - developmental surveillance and early intervention
 - Specialist follow up of nutritional problems (severe acute malnutrition, obesity etc.) among referred children with special needs
 - Specialist follow up of referred children with chronic illnesses such as epilepsy, asthma, nephrotic syndrome and other disabilities etc.
2. To act as the team leader who will assess and define management plan, train parents/care givers on implementing management plans of special needs children referred by the PHC teams and other relevant bodies.
3. Consultant community paediatrician will attend to referrals made by Medical Officers of Health (MOH), medical officers at primary level hospitals, paediatricians, and other consultants, and general practitioners, officers attached to social services, probations department, NCPA, Police and education department. Back referrals should be made to the relevant officer who made the original referral. Field follow up if necessary to be arranged through the MOH team?
4. Provide outreach clinical services
 - Organize outreach services for children with special needs
5. Contribute to the management of children with safeguarding and abuse issues when required
 - Assess, manage and follow up children and adolescents at risk of child abuse/neglect and exploitation referred to the center and also those in state and non-state childcare institutions.
 - Participate in relevant legal matters
6. Networking and communication with relevant stakeholders
 - Collaborate with general pediatricians, child psychiatrists, judicial medical officers, psychologists, Preventive health staff, National Child Protection Authority, Probation and childcare Department, Social service department and social workers including Psychiatric social workers, Police, Non-Governmental Organizations, and other groups as required

- Provide technical expertise and participation in relevant preventive health programmes.
 - Support the development of national guidelines and care pathways for children with developmental needs with the participation of other stakeholders
7. Capacity building of relevant health staff
 - Provide academic leadership through teaching, training and research
 - Training of medical, paramedical and other relevant staff on child development and children with special needs
 8. Monitoring and evaluation
 - Participate and contribute to relevant reviews.
 - Maintain and report management information to relevant authorities
 - To participate in clinical audit activities
 9. Research
 - Promote and participate in research activities related to children with special needs
 10. Update him or herself with latest knowledge
 - Participate in CPD activities to update his or her knowledge

C. Person Specifications

C1. Minimum Educational Qualifications:

Board certified as a specialist in community pediatrics

C2. Skills required:

Clinical skills to apply broad and holistic perspective to patient care, continuous responsibility for patient care, coordinating care, manage a wide range of patients and conditions, basic human resource management and administrative skills, good communication skills and IT skills

C3. Competencies (General & Career):

Act as a communicator, scholar, collaborator, team leader, care provider, researcher, teacher and trainer

C4. Special circumstances affecting the job, associated risks/working conditions:

May take part in legal proceedings related to children with child abuse

C5. Service Standards:

Standards that are issued by the Ministry of Health shall be followed

C6. Values and ethics:

Ensure dignity and respect towards patients, community, fellow professionals and curative and preventive health staff. Ensure confidentiality in patient management. Ensure rational use of government resources minimizing wastage.

C7. Responsibility of facilities and resources:

Efficient use of resources in the SCDC

Monday to Friday - 8.00 am - 12.00 noon, 2.00 pm - 4.00 pm

Saturday - 8.00 am - 12 noon
