Efficiency Bar Examination for Grade I Nursing Officers in the Nursing Service – 2024 (1st Term)

According to the Sri Lanka Nursing Service Minute published in extra ordinary gazette notification No 1837/8 and 19.11.2013 dated, it is notified hereby that the Efficiency Bar Examination to be passed within five years after they promoted to the Grade I Nursing Officers will be held on 17/03/2024 in Sinhala, Tamil and English medium. The venue and the time will be notified in the admission card.

02. Qualifications

- Officers promoted to / absorbed into Grade I can apply to this Efficiency Bar Examination.
- From the Nursing officers who are absorbed into Grade I, the nursing officers who have completed on active Service period of 5 years in Grade I as at 01.11.2010 will be exempted from the 3rd Efficiency Bar Examination.
- And also the nursing officers who are in the posts of Grade I Nursing Officer (Hospital services/Education/Public Health) after following Diploma Course of 1½ years the post Basic Nursing School (National Institute of Nursing Education) will be exempted from this Efficiency Bar Examination.

 All other Nursing officers who are in Grade I, are compulsory to pass this efficiency bar examination.
- All Nursing officers promoted to Grade I after 01.11.2010 should sit for this Efficiency Bar Examination.

N.B: Take necessary actions to send applications of the officers only who has been promoted to Grade I by 02/02/2024 and already received the appointment letter.

03. Applications

Applications prepared by the candidates as per specimen appended to this letter should be sent under registered cover to reach the Director (Examinations) No. 385, "Suwasiripaya" Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 02/02/2024 through their Heads of Institutions. The name of the examination applied for should be mentioned as "Efficiency Bar Examination for Grade I Nursing Officers in the Nursing Services – 2024 (1st Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. One (01) self-addressed envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

N.B.: Applications should be prepared in compliance with the specimen form of application in the size of A4 using in such a way that No 01 to 04 appear on the first page whilst the No 05 to 10 appear on the second page.

04. Examination Fees

- 4.1 The applicants for the first time will be exempted from exam fees. The others who had applied for but not sat the Examination shall affix stamps to the value of Rs. 25/= per subject in the application and cancel them by placing their signatures and the date.
- 4.2 Under no circumstances the fees once paid will be refunded or changed for another Examination.

05. Admission to the Examination

- 5.1 Admission cards will be issued for properly perfected applications. The applicants should perfect the admission card and hand them over to the supervisor at the Examination. Otherwise they will not be allowed to sit the examination.
- 5.2 The applicants shall establish their identity to the supervisor within the Examination center by producing one of the following.
 - (a) National Identity Card
 - (b) Departmental Identity Card or valid official identity card
 - (c) Valid Driving License
 - (d) Valid Passport

06. Scheme of the Examination

This Efficiency Bar examination consists of two essay type question papers which are **General Management** and **General Nursing.** Duration is **03 hours** for each question paper and each paper will receive **100 marks**. Applicants shall secure minimum of 40 marks to have a pass in the Examination. They can complete the examination at once or several occasions. At the first attempt officers should apply for all relevant subjects.
