The venue and the time of the examination will be mentioned on the admission card.

02. Qualifications:

The officers who have obtained a Grade I appointment a post of in Field Officer / in Office Officers Segment 02 Service category (MN -5 - 2006 (A)) of Ministry Of Health (Nutritionist, Psychiatric Social Worker, Planning and Program Officer, Medical Record Officer, Statistic Survey Officer, Perfussionist) and have not yet completed this examination, are only eligible to apply for this examination.

N.B Take necessary actions to send applications of the officers only who have been promoted to Grade I as at 10.08.2024 which is the closing date of applications. (it is mandatory to attach a certified copy of Grade I appointment letters along with the applications)

03. Applications:

Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 10.08.2024 .through their Head of Institutions. The name of the examination applied for should be mentioned as "Second Efficiency Bar Examination for the officers in Grade I of the Field / In Office Officers (MN – 05 – 2006 (A)) - 2024 (Second Term) on the top left corner of the envelope. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. one self-addressed envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs.110.00 should be sent along with the application. No candidate should attempt to look at the script of another candidate and should not help any candidate either help another candidate or obtain help from another candidate or person.
