Second Efficiency Bar Examination for the Posts Belonging to the Salary Scale PL - 02 - 2006 (A) of Primary Semi - Technical Service Category of Ministry of Health - 2024 (1st Term)

It is hereby notified that the second efficiency bar examination for the posts of Primary Semi Technical Service Category in the Ministry of Health for which the prescribed salary scale is (PL- 02-2006 (A)) and which should be passed before expiry of 03 years after promotion to Grade II, will be held on **01/09/2024** in the Sinhala, Tamil and English medium .The venue and the time of the examination will be notified along with the Admission Card.

02. Qualifications:

The employees who are serving in a post under the Primary Semi Skilled Service Category for which the prescribed salary scale is (PL-02-2006 (A)) (Painter, Fork Lift Operator, Generator Operator (**Old Designation - Machine Operator**), Boiler Operator, Shoe Maker, Animal Supervisor, Orthopaedic Technical Assistant (**Old Designation - Limb Maker & Surgery Equipment Maker**), Dark Room Assistant, Entomological Field Attendant, Plumber/ Pump Operator, Bungalow Keeper, Barber, Carpenter, Leather Worker, Welder, Connector, Metal Worker, Corsetiere, Lathe Machine Operator, Mason, Blacksmith, Cook, Sewing Operator, Painter (Artist), Health Laboratory Aide (**Old Designation - Lab Assistant**), Attendant, Telephone Operator,) have been absorbed into Grade II promoted to Grade II and have not completed the examination upto now, are only eligible to apply for this examination.

N.B: Please take action to send me the applications of the officers only who have been appointed to or absorbed into Grade II by 07/08/2024 and already have received relevant letters of appointments. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application)

03. Officers exempted from the Efficiency Bar Examination

Officers who have completed a satisfactory minimum service period of 13 years in a following post as at 14.08.2012 are exempted from the Efficiency Bar Examination prescribed for Grade II (from the Second Efficiency Bar Examination) in the relevant post. (Officers appointed to the post concerned before 14.08.1999 and absorbed into Grade II are eligible for exemption.)

04. Applications:

Applications prepared by the candidates in accordance with the specimen form of application appended at the end of this circular should be sent by registered post to reach Director (Examinations), Ministry of Health, "Suwasiripaya", No. 385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10 on or before 07/08/2024 through the respective Head of Institution. "Second Efficiency Bar Examination of PL - 02 - 2006 (A) - 2024 (1st Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self addressed 01 envelope (Candidates can write their Official or private address) in the size of 9"x4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications which are received late, incomplete or inaccurate will be rejected without notice.

N.B.: Applications should be prepared using a paper of A4 size in such a way that the No 01 to 04 appear on the first front page and the No. 05 to 09 appear on the second page. Applications that do not comply with the specimen will be rejected without any notice.

Examination Fees:

- I. Candidates who sit the examination for the first time are exempted from paying examination fees. Other candidates should affix stamps to the value of Rs. 25/= per subject in the application and cancel the same by placing their signature and date.
- II. The examination fees paid will not be transferred or refunded to other examinations under any circumstances.

Admission to the Examination:

- I. Admission cards will be issued to the candidates whose applications are accepted. They should be duly completed and submitted to the supervisor at the examination center. Otherwise, the candidate will not be allowed to sit for the examination.
- II. Candidates should prove their identity to the Supervisor at the examination hall. For this purpose, one of the following documents will be accepted.
 - a) National Identity Card
 - b) A formal Identity Card issued by the Ministry of Health or a relevant institution.
 - c) Valid Driving License
 - d) Valid Passport

Scheme of the Examination

- This examination consists of two papers viz. “Establishments Code and Financial Regulations”, and “Subject Knowledge”.
- Establishments Code and Financial Regulations paper consists of a multiple choice and structured questions. Duration is 2 hours. Total marks is 100 and minimum of 40% marks should be obtained to pass the examination.
- Subject Knowledge paper consists of a multiple choice and structured questions. Duration is 01 hour. Total marks is 100 and minimum of 40% should be obtained to pass the examination.


