Efficiency Bar Examination for Public Health Midwives belonging to the paramedical service who are in Seg. II "A"/ Grade II and on the salary scale (MT – 05) in the Ministry of Health – 2024

It is hereby notified that the Efficiency Bar Examination which should be passed by Public Health Midwives in seg II "A" /Grade II with in three years from the date of promotion to Grade II, will be held on 26/10/2024 and 27/10/2024 respectively in the medium of Sinhala, Tamil and English .The venue and the time of the examination will be notified along with the admission card.

02. Qualifications

Officers who have been appointed to a post of family health officer in class II Segment "A" / Grade II, and not yet completed this examination are only eligible to apply for this examination.

N.B Take necessary actions to send applications of the officers only who has been promoted to grade II by 20/09/2024 already received the appointment letters.

(It mandatory to attach a certified copy of Grade II appointment letter along with the application)

03. Applications

Applications prepared by the candidates as per specimen appended to this circular should be sent under registered cover to reach the Director (Examinations) "Suwasiripaya" No.385, Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 20/09/2024 through the respective Head of Institution. The Name of the examination applied for should be mentioned as "Efficiency Bar Examination for Public Health Midwives Seg. II "A"/ Grade II – 2024" top left corner of the envelope. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination Two self addressed envelopes (Candidates can write two official or private address) in the size of "9 x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications which are received late, incomplete or inaccurate will be rejected.

Note: The application should be prepared using an A4 paper based on the accommodate from 01 to 04 on the first page and from 05 to 09 on the second page. Applications which are not compliance with the specimen from will be rejected without any notice.

04. Examination fees:-

- I. Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of Rs. 25/= per subject in the application and cancel the same by placing their signature and the date.
- II. The fees once paid will not be allowed to transfer for any other examination or refunded for any reason.

05. Admission to the Examination:-

- Candidates whose applications are accepted will be issued with admission cards. The Admission
 card should be duly completed and submitted same to the supervisor at the examination centre.
 Otherwise they will not be allowed to sit the examination.

Efficiency Bar Examination consists to two papers viz. **Establishments Code and Financial Regulations.** Each part is given 100 marks. Minimum 40 marks should be obtained for each subject to pass the examination.

The examination can be completed in one or several sittings. Applicants who sit for the examination for the first time should apply for all subjects.
