The following provisions shall be effective from the date of issue of this circular, regarding the second Efficiency Bar of the Officers in the Posts of Physicist, Bio Chemist, Research Officer, Entomologist, Chemist, Parasitologist, Pharmaceutical Analyst, Scientific Officer, Molecular Biologist and Regional Malaria Officer in the Sri Lanka Scientific Service serving under the Ministry of Health and Provincial Health Service.

- 02. According to the Service Minutes of Sri Lanka Scientific Service/ Recruitment Procedure related to the above posts, the officers of in the above Posts have to complete the second Efficiency Bar requirement within 03 years after being promoted to grade II of the Sri Lanka Scientific Service.
- 03. There by, subject to the following conditions, a report for original research related to the field of work, or a Research Paper/Abstract that has been published so far, or a relevant research report after completing an ongoing research, must be submitted.
- 04. The applicant must certify the information submitted by the applicant himself, and the approval for the relevant information will be granted by the following committee delegated authorization by the Secretary of the Ministry of Health. The committee will decide whether the applicant has completed the second efficiency Bar or not.

- I. Director (Research) (Chairman)
- II. An officer in the Scientific Service in the Ministry of Health, recommended by the Deputy Director General of the ET&R Section appointed by the Secretary of the Ministry of Health.
- III. A reviewer recommended by the Deputy Director General of the ET&R Section and appointed by the Secretary of the Ministry of Health with standards educational background (Ex: university) related to scientific service.
- 05. Officers who have been promoted to Grade II on or before 31.01.2024 and who are expected to submit an original research paper/abstract already published to be considered for the second Efficiency Bar requirement, should submit an Original research paper/Abstract which is related to their field of work and with their authorship as the first three authors and who can clearly state their contribution to the task, using the format A to the Director (Research) of Education, Training and Research Unit in the Ministry of Health. The relevant original research paper should have been published in an International or Local Level Journal/Magazine accepted by the committee mentioned in above 04 and if it is an Abstract should have been published in an International or Local Level Conference accepted by the committee mentioned in the above 04. (The criteria to be considered by "The Evaluation Committee" are indicated in Annexure 1.)
- 06. Officers who have been promoted to Grade II on or before 31.01.2024 and who are expected to submit the relevant research report after completion of an ongoing research to be considered for the approval of the committee mentioned in 04 of the above, regarding whether the research can be considered for completing the relevant second Efficiency Bar requirement, should have to use "Form B" indicated in the Annexure 03 and submit the same, to the Director (Research) of Education, Training and Research Unit in the Ministry of Health. If it will be approved by the committee, after completing the relevant research, the final report should be submitted to the Director (Research) of the Education, Training and Research Unit in the Ministry of Health to be submitted to the committee mentioned in the above 04 for evaluation.
- 07. Officers who are promoted to Grade II on or before 31.01.2024 and be determined to commence a new research for the requirement of the Second Efficiency Bar, the research proposal should be submitted to the Director (Research) of the Education, Training and Research Unit in the Ministry of Health using the format in the Annexure 03 to acquire the approval of the committee mentioned in 04 of the above. In accordance with the instructions of the Committee, after completion of the research, the final report should be submitted to the Director (Research) of the Education, Training and Research Unit of the Ministry of Health by using "Form C" in the annexure 04, for submission to the committee mentioned in the above 04, to be evaluated.
- 08. Officers who have been promoted to Grade II after 31.01.2024 should submit their research proposal to the Director (Research) of the Education, Training and Research Unit in the Ministry of Health using the format in the Annexure 04 to obtain the approval of the committee mentioned in the 04 of the above. In accordance with the instructions of the Committee, after completion of the research, the final report should be submitted to the Director (Research) of the Education, Training and Research Unit of the Ministry of Health by using "Form D" in the annexure 05, for submission to the committee mentioned in the above 04, to be evaluated.
- 09. When applying for the second Efficiency-Bar, the application prepared by the applicant in accordance with the attached format, should be submitted with the following documents along with the recommendations of the head of the institution, and it is compulsory that the Head of the Institution has certified that the given information is correct.

- I. Certified copy of the National Identity Card
- II. If necessary for the research, Ethical clearance and Institutional clearance and
- III. If it is currently published as an abstract of a conference proceedings a certified hard copy or if it is a journal (Full paper/Abstract) publication, a printed copy with DOI number
- 10. Research Theses prepared as a requirement for completing an academic qualification cannot be utilized to complete this Efficiency-Bar requirement, and the applicant who attempt for the first-time will be released from examination fees. Also, the applicants appearing more than once should have to affix a stamp of Rs.25/- on the Research Report or Research Paper/ Abstract or Research Proposal submission format, and cancel the stamps by the signature and date.
- 11. Payments will be made for the members of the Research Evaluation Committee as per Management Services Circular No. 02/2014, and in the case of any ambiguity between the texts of the Sinhala, Tamil and English notices in this General Circular letter, the Sinhala notice shall prevail. You are kindly requested to inform all the officers who are serving in your Hospital/Institute in this regard.

REQUIREMENT FOR SECOND EFFICIENCY BAR EXAMINATION: SRI LANKA SCIENTIFIC SERVICE GUIDELINES FOR CANDIDATES

Instructions to be followed by the candidates;

A. Submitting a Proposal:

- 1. Before carrying out the research, candidate should submit the title, brief introduction, statement of objectives, methodology, budget outline and a time frame (minimum word count of 1000) to the office of the Director, Research, (Education/Training and Research Unit of the Ministry of Health) with application form "C"
- 2. The proposed project shall be a research study.
- 3. It would be necessary that it contains data gathered scientifically from the candidates' own investigations and not limited to data from available literature.
- 4. The title should be relevant to the field of work the candidate is engaged in.
- 5. Candidate should select his/her supervisor and submit the name along with the proposal
- 6. This proposal will be evaluated by a reviewer appointed by MOH, based on
 - a. MoH Representative; Director Research or a Suitable Nominee by the DDG/ ETR
 - b. A senior lecturer from a government university in the relevant field of study
 - c. Class 1 Officer from the Sri Lanka Scientific Service, affiliated to the MoH and Nominee by Collage of State scientists. The nominee will be selected from the list of eligible candidates provided by the College of State Scientists accordingly

B. Conducting the research and preparing the manuscript;

- 1. Following approval of the title and the supervisor, candidate should consult the supervisor and obtain guidance at all stages of the research, including during the preparation of the manuscript.
- 2. The necessary ethical and administrative approval should be obtained (where applicable)
- 3. The candidate shall submit the final manuscript to the office of the Director, Research, ETR of the MoH with application form "D"
- 4. It is recommended that the manuscript must be between 3000 to 5000 words
- 5. It should be type-written using double spacing on good quality A4 size paper on one side only.
- 6. A margin of not less than 44 mm should be allowed on the left and not less than 25mm on the top, right hand side and the bottom.
- 7. Chapter headings should be capitalized and centered, whilst subdivision headings should be typed from the left hand margin in lower-case type and underlined.
- 8. Tables and figures should be placed as near as possible to the part of the text to which they refer.
- 9. Contents of the manuscript should be given under the following headings. The marks are indicated in brackets.
 - a) Title (05)
 - b) Author's name and address
 - c) Abstract (10)
 - d) Table of contents
 - e) List of tables
 - f) List of figurers

- g) Introduction (20)
- h) Objectives (15)
- i) Review of literature (20)
- j) Materials and methods (50)
- k) Results (40)
- 1) Discussion (including limitations) (45)
- m) Conclusion and recommendations (10)
- n) Acknowledgements
- o) References (15) (Harvard system should be used)
- p) The overall presentation (20 marks)
- 10. The front cover should carry the title on top of the author's name in the center and the year at the bottom

C. Submitting the manuscript;

- A hard copy of the manuscript should be submitted to the office of the Director, Research, ETR, MOH
- 2. Along with the hard copy, a soft copy should also be handed over as a CD/Pen drive.
- 3. Additional hardcopy may be requested by Director Research unit as request.

D. Pass/Fail Status:

- 1. Passing Criteria: The candidate will pass the exam if at least two out of the three reviewers assign a score of 50% or higher.
- 2. Failure Criteria: If at least two out of the three reviewers assign a score of less than 50%, the candidate will fail the exam.
- 3. Action for Failed Candidates:
 - For candidates scoring between 30% to less than 50%, appropriate revisions should be made and resubmitted within three months for fresh marking.
 - If the score is less than 30%, the candidate must submit a fresh or modified manuscript as prescribed by the reviewers.
- 4. Reviewers shall remain anonymous at all stages

E. Reviewers:

1. Additional Secretary, Medical Services in consultation with the Director Research and DDG, ETR will identify and appoint suitable reviewers based on above criteria.

F. Appeals:

- 1. Candidates will be allowed to submit one appeal within two weeks of the issuing of results in a subscribed format
- 2. Each appeal will be considered on a case-by-case basis
- Appeal Board will be chaired by the Additional Secretary, Medical Services and will consist of
 - a) DDG, ETR
 - b) Director Research, ETR
 - c) Another reviewer from the list; one other than the original reviewers of the relevant field.
- 4. Appeal board decision will be final and binding.

3	Editorial Board	The journal should have an editorial board composed of respected and well-known experts in the relevant field, ensuring the journal's academic integrity and quality.
4	Ethical Standards and Transparency	The journal must adhere to high ethical standards, including policies on conflict of interest, plagiarism, and research misconduct, as well as transparency in publication practices.
