# Efficiency Bar Examination for the Officers in Grade III of the Post of Speech Therapist belonging to the Service of Professions Supplementary to Medicine (Salary Scale MT-06) of the Ministry of Health – 2024 (1st Term)

It is hereby notified that the efficiency bar examination which should be passed before expiry of three years from the date of recruitment to Grade III of the post of Speech Therapist belonging to the Service of Professions Supplementary to Medicine will be held on 31/03/2024 in the medium of Sinhala, English and Tamil. The venue and time of the examination will be mentioned on the admission card.

#### 02. Qualifications

Officers only who have not yet reach the 4th salary step and not completed this examination after receipt of the appointment as a Speech Therapist, may apply for this examination.

#### N.B.

- Officers who have passed the two subjects, Office Systems and Financial Regulations prescribed in
  the Old Scheme of Recruitment are exempted from the Departmental Regulations prescribed for the
  first efficiency bar examination in the Old Scheme of Recruitment from the date of approval of the
  New Scheme of Recruitment.
- Officers who have passed only one subject out of the two namely Office Systems and Financial Regulations prescribed in the Old Scheme of Recruitment will be deemed to have completed the first efficiency bar examination and exempted from the examination after passing the corresponding subjects prescribed for the efficiency bar examination in the New Scheme of Recruitment.

### 03. Applications

Applications prepared by the candidates as per specimen appended to this letter should be sent under Registered cover to reach the Director (Examinations) No.385, "Suwasiripaya" Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 28/02/2024 through their heads of institutions. The name of the examination applied for should be mentioned as "Efficiency Bar Examination for Speech Therapist Grade III - 2024 (1<sup>st</sup> Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of the personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination head of division. One self-addressed envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

Note: The application should be prepared using an A4 paper based on the specimen form of the application so as to recommended from 01 to 04 on the first front page and from 05 to 09 on the second page. Applications which do not conform to above will be rejected without any information.

#### 04. Examination fees
