Efficiency Bar Examination for Officers in the post of Public Health Inspector in Grade III on the Salary Scale (MT – 05) belonging to Paramedical Service of Ministry of Health – 2025 (1st Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by officers in the post of Public Health Inspector in Grade III before expiring three (03) years from the date of appointment to Grade III, will be held on 02/02/2025 in the medium of Sinhala, Tamil and English. The venue and the time of examination will be notified in the admission card.

02. Qualifications

The officers who have been appointed to the post of Public Health Inspector in Grade III as at 02/02/2025 and not yet completed this examination, are only eligible to apply for this examination.

03. Exemption from the Efficiency Bar Examination

As per the new scheme of recruitment approved by the Public Service Commission on 22.09.2016. in terms of the Public Administration Circular No. 06/2006, officers who have already passed the subjects i.e., Establishments Code and Financial Regulations of the first efficiency bar examinations under the old scheme of recruitment, are exempted from the first Efficiency Bar Examination included in the new scheme of recruitment.

04. Applications

Applications prepared by candidates as per specimen form appended to this circular letter should be sent through the respective Heads of Institutions to reach "Director (Examinations). No. 385, "Suwasiripaya", Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10" on or before 04/12/2024 by registered post. The words "Efficiency Bar Examination for Public Health Inspectors in Grade III – 2025 (1stTerm)" should be mentioned on the top left corner of the envelop. It is mandatory to have certify fact that the candidate had satisfied the qualifications required to sit for the said Efficiency Bar Examination by the officer in-charge of the subject of personal file and that all the particulars furnished in each application are correct by the Head of Institution. And, one (01) self-addressed envelope (candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs.110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without any notice.

Note: The application should be prepared using an A4 paper based on the specimen form of application so to recommended 01 to 04 on the first page and from 05 to 09 on the second page. Applications that do not comply will the above format will be rejected without further notice.

05. Examination fees: -

- I. Candidates who sit the examination for the first time, will be exempted from examination fees. However, in every subsequent sitting, they should affix stamps to the value of Rs. 25/= per subject in the application and cancel the same by placing their signature and the date.
- II. The fees once paid will not be transferred to other examinations or refunded under any circumstances.

06. Admission to the Examination: -

- I. Candidates whose applications have been accepted, will be issued with Admission Cards. The Admission card should be duly completed and submitted same to the Supervisor at the Examination Centre. Otherwise, they will not be allowed to sit the examination.
- II. Candidates should prove their identity to the Supervisor at the examination hall. For this purpose, one of the following documents will be accepted.
 - (a) National Identity Card
 - (b) An Identity Card formally issued by the Ministry of Health or a relevant Institution
 - (c) valid Driving License
 - (d) valid Passport.

07. Scheme of the Examination: -

This Efficiency Bar Examination consists of two papers viz. Establishments Code and Procedural Rules and Financial Regulations. Total Marks of 100 will be given for each paper. Candidates should obtain at least 40% marks for each paper to pass the examination. The examination can be completed subject by subject at one sitting or at several sittings. At the First attempt officer should apply for all relevant subjects.

Duration is 03 hours. The question paper consists of 08 essay-type questions and candidates are required to answer any 05 questions out of them. Total Mark is 100.
