First Efficiency Bar Examination for the Prosthetist and Orthotist Grade III Service Category (MT-6) of the Ministry of Health – 2025 (First Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by Prostheist and Orthotist Grade III before reaching the third salary step of the salary scale relevant to Grade III will be held on 26/01/2025 in Sinhala, Tamil and English medium. The venue and the time of the examination will be notified in the admission card.

02. Qualifications

Officers who have been appointed to a post of Prostheist and Orthotist Grade III and Prostheist and Orthotist Grade III are only eligible to apply for this examination.

03. Applications

Applications prepared by the candidates in accordance with the specimen form of application appended to this cirecular should be sent by registered post to "Director (Examinations) Ministry of Health, Suwasiripaya, No.385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 23/12/2024 through the respective Heads of Institutes. The name of the examination applied for should be mentioned as "First Efficiency Bar Examination for the Prosthetist and Orthotist Grade III – 2025 (First Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self addressed 01 envelope (Candidates can write their Official or private address) in the size of 9"x4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications which are received late, incomplete or inaccurate will be rejected without notice.

Note: The application should be prepared using a paper of size A4 in compliance with the specimen form of application so as to appear from 01 to 04 on the first side of the page and from 05 to 09 on the second side of the page. Applications which do not conform to above format will be rejected without any notice.

04. Examination fees:-

- I. Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of Rs. 25/= per subject in the stamps cage provided for in the application and cancel the same by placing their signature and the date.
- II. The fees once paid will not be allowed to transfer for any other Examination or refunded for any circumstances.
