The venue and the time of the examination will be mentioned on the admission card.

02. **Qualifications:**

The officers who have obtained a Grade I appointment in a post of in Field Officer / in Office Officers Segment 02 Service category (MN -5 - 2006 (A)) of Ministry Of Health (Nutritionist, Psychiatric Social Worker, Planning and Program Officer, Medical Record Officer, Statistic Survey Officer, Perfussionist) and have not yet completed this examination, are only eligible to apply for this examination.

N.B Take necessary actions to send applications of the officers only who have been promoted to Grade I as at 24.12.2024 which is the closing date of applications. (it is mandatory to attach a certified copy of Grade I appointment letters along with the applications)

03. Applications:
