Placement of End Post of Specialist Medical officers – 2024

Applications are invited from suitably qualified Specialist Medical Officers for end posts in the Ministry of Health. List of end posts available for Specialists Medical Officers under different specialties is attached.

1. All end posts which are marked as vacant are definitely vacant.
2. All other end posts where Specialist Medical Officers have occupied are to be considered as potentially vacant as those Specialist Medical Officers are eligible to apply to for transfer to another vacant end post of this list and their end post may fall vacant.
3. All posts are coded with unique numbers and therefore in the event of multiple posts in the same specialty in the same institution, the applicants are expected to be specific in selection and they will be posted accordingly.
4. All Specialist Medical Officers who have been promoted to specialist grade by the health Services committee of the Public Services commission by 13 /12 / 2023 are eligible to apply for the posts in their respective fields and applications will not be accepted from officers who claim eligibility of pending approval of the Health Service Committee of the Public Services Commission.
5. Specialists Medical Officers are requested to apply in their preference order.

6. It is not compulsory for Specialist Medical Officers to apply for this end post transfers.
7. Eligible applicants those who are willing to apply are hereby requested to send in their application via online. The online application is available at **medserv.health.gov.lk**. The online system will be ready for application from 01/12/2023 onwards till 13/12 /2023. Application submitted after the closing date will not be accepted.
8. Applicants should forward their applications from their duly appointed station from the immediate past Annual Transfers / End Post placement. Applications will not be entertained if submitted through any station other than his/her due station. Upon submission of the online application, a printout should be taken for certification by the respective Head of the Institution. The certified application should be sent to Director (Tertiary Care Services) via post and fax to reach on or before 23 / 12 /2023.

9. The end post placement for the year of 2024 which will be effective form 01 / 01 / 2024 and will be done as per the health services minute appearing in the Government Gazette no. 1176/15 dated 22nd March 2001 and points will be calculated accordingly, up to 13 .12.2023.
10. Those who wish to withdraw the application can do so by giving it in writing to Director General of Health Services though the head of the respective institutions within one week of the closing date. No subsequent withdrawal will be entertained and if the applicant is selected to a post, he/she is compelled to take up that post. Changing of preference order will be not allowed after closing date of application.
11. Please note that undergraduate and Post graduate teaching and training is an essential part of duties of all Specialist Grade Medical Officers occupying end posts.
12. Once all applications are considered for definitely vacant posts and potentially vacant posts any remaining vacancies will be available for appeals. Please note that only those applicants who applied for main end post transfer are eligible to apply for appeal.
13. If a Specialist Medical Officer has an issue with end post vacancy list in a particular specialty, it should be informed to the Director, TCS, Ministry of Health (within one (01) week after published).
14. Heads of the institutions are requested to bring the content of this circular to the notice of all Specialist Medical Officers in their institutions.
15. "The Notification is published with the consent of the Health Service Committee of the Public Service Commission".
