# First Efficiency Bar Examination for the posts of Control Room Operator, Automobile Technician, Overseer, Electrician and Cinema Machine Operator which are entitled to the salary scale PL – 03 - 2006(A) of Primary Technical Service Category of Ministry of Health – 2024 (First Term)

It is hereby notified that the First Efficiency Bar Examination which should be passed by officers in the posts of Control Room Operator, Automobile Technician, Overseer, Electrician, Cinema Machine Operator and of Primary Technical service category for which salary scale PL - 03 - 2006 (A) is stipulated of Ministry of Health before expiry of 03 years after promoted to Grade III will be held on 10/03/2024 in Sinhala, Tamil and English medium. The venue and time of the examination will be mentioned on the admission card.

#### 02. Qualifications

Only the officers who have got a appointment in Grade III in a post (Control Room Operator, Automobile Technician, Electrician, Overseer, Cinema Machine Operator and) for which salary scale PL - 03 - 2006 (A) is stipulated of Primary Technical service category of Ministry of Health and those who have not yet completed the examination are eligible to apply for this examination.

#### N.B.:

As mentioned in the General Circular Letter No.02-90/2015 dated 12.08.2015 of the Secretary of the Ministry of Health, Nutrition & Indigenous Medicine, the officers who have exceeded 3 years in the Grade III in the Posts of Electrician and Cinema Machine Operator as at 27.07.2012 need not appear for this examination, since such officers are exempted from this efficiency bar examination.

### 03. Applications

Applications prepared by the candidates as per specimen appended to this circular should be sent under Registered cover to reach the Director (Examinations) "Suwasiripaya", No.385, Rev. Baddegama Wimalawansa Thermo Mawatha, Colombo 10, on or before 10/01/2024 through their heads of institutions. The name of the examination applied for should be mentioned as "First Efficiency Bar Examination of PL – 03 – 2006 (A) of Ministry of Health – 2024 (First Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of the personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self-addressed 01 envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

Note: The Applications should be prepared using an A4 Paper based on the Specimen from of applications so to recommended 01 to 03 on the first Page and from 04 to 08 on the second Page Applications that do not comply with the above format will be rejected without notice.

#### 04. Examination fees:-

- Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of Rs. 25/= per subject in the stamps cage provided for in the application and cancel same by placing their signature and the date.

Minimum 40 marks should be obtained to pass the examination. Duration is one hour.
