It is hereby notified that the Efficiency Bar Examination which should be passed by Public Health Laboratory Technicians in Seg. II "B" / Grade III before expiring three (03) years from the date of appointment to Grade III, will be held on 05/05/2024 in the medium of Sinhala, Tamil and English. The officers who have been appointed to the post of Public Health Laboratory Technicians in class Segment Seg. II "B" / Grade III by 15/03/2024 and not yet completed this examination, are only eligible to apply for this examination.

63. Exemption from the Efficiency Bar Examination

As per the new scheme of recruitment approved by the Public Service Commission on 25.09.2018, according to the Public Administration Circular No. 06/2006, officers who have already passed the subjects **Establishments Code and Procedural Rules** and **Financial Regulations** of the first efficiency bar examinations under the old scheme of recruitment procedure are exempted from the first efficiency bar examination included in the new recruitment procedure.

04. Applications

Applications prepared by candidates as per specimen form appended to this circular letter should be sent through the respective Heads of Institutions to reach "Director (Examinations), No. 385, "Suwasiripaya", Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10" on or before 15/03/2024 by registered post. The words "Efficiency Bar Examination for PHLT Grade III – 2023 (2nd Term)" on the top left corner of the envelope. It is mandatory that have certify fact that the candidate had satisfied the qualifications required to sit for the said efficiency bar examination by the officer in - charge of the subject of personal file and that all the particulars furnished in each application are correct by the Head of Institution. And, one (01) self-addressed envelope (candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs.110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without any notice.

Note: The application should be prepared using an A4 paper based on the specimen form of application so to recommended 01 to 04 on the first page and from 05 to 09 on the second page. Applications that do not comply will the above format will be rejected without further notice.

05. Examination fees: -
