# Efficiency Bar Examination for Dispenser (MT -04-2016) belonging to the Paramedical Service Grade III in the Ministry of Health – 2024 (1st Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by Dispenser belonging to the Paramedical service Grade III with in three years from the date of appointment to Grade III will be held on 05/05/2024 in Sinhala, Tamil and English medium. The venue and the time of the examination will be notified along with the admission card.

#### 02. Qualifications

The officers who have been appointed to Dispenser Grade III, and not yet completed this examination are only eligible to apply for this examination.

#### 03. Applications

Applications prepared by the candidates as per specimen appended to this letter should be sent under Registered cover to reach the Director (Examinations) No.385, "Suwasiripaya" Ven.Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 10/04/2024 through their Heads of Institutions. The name of the examination applied for should be mentioned as "Efficiency Bar Examination for Dispenser Grade III in the Ministry of Health – 2024 (1st Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of the personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. One self-addressed envelope (Candidates can write their official or private address) in the size of "9 x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

Note: The application should be prepared using an A4 paper based on the specimen form of application so as to accommodate from 01 to 04 on the first page and from 05 to 09 on the second page. Applications which do not conform to above will be rejected without any information.

### 04. Examination fees:-

- Candidates who sit the examination for the first time need not pay examination fees.
  However, in every subsequent sitting they should affix stamps to the value of Rs. 25/= per
  subject in the stamps cage provided for in the application and cancel same by placing their
  signature and the date.
- ii. The fees once paid will not be refunded or transferred to other examinations under any circumstances.

### 05. Admission to the Examination:-

- Candidates whose applications have been accepted will be issued with Admission Cards. They should duly complete and submit same to the Supervisor at the Examination centre. Otherwise, they will not be allowed to sit the examination.
- II Candidates should prove their identity to the Supervisor at the examination hall. For this purpose one of the following documents will be accepted.
  - (a) National Identity Card
  - (b) A formal Identity Card issued by the Ministry of Health or a relevant Institution
  - (c) Valid Driving License
  - (d) Valid Passport

### 06. Scheme of the Examination:-

This examination consists of two papers with essay type question paper and these are **Establishments Code & Procedural Rules** and **Financial Regulations.** Duration is 3 hours for each paper. Candidates should obtain at least 40% marks for a paper to pass the Examination. Total Marks of 100 will be given for each paper. Applicants can complete the examination in one sitting or in several.
