It is hereby notified that the Efficiency Bar Examination which should be passed by the Legal officers of the Ministry of Health before expiration of three years from the date of appointment to Grade II in the post of Legal officer wich belongs to Exceutive category of service and the prescribed salary scale for which is SL-01 - 2006 will be held on 19/05/2024 in Sinhala, English, Tamil medium. The venue and the time of the examination will be notified along with the admission card.

02. Qualifications

Only the officers of the Ministry of Health and Indigenous Medical Services who have been appointed to grade II in a post of Legal Officers or chief Leegle officer belonging to Executive category of Service prescribed salary scale for which is SL - 01 - 2006 and the officers who have not completed the examination upto now will apply for this examination.
