Efficiency Bar Examination for School Dental Therapists belonging to the Paramedical Service who are Grade II and on the salary scale (MT -06) in the Ministry of Health 2024 (First Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by School Dental Therapists Grade II within three years from the date of promotion to Grade II, will be held on 18.05.2024 and 19.05.2024 respectively in the medium of Sinhala, Tamil and English. The venue and the time of the examination will be mentioned in the admission card.

02. Qualifications

Officers who have been appointed to a post of School Dental Therapists Grade II, and not yet completed this examination are only eligible to apply for this examination.

N.B: Take necessary actions to send applications of the officers only who has been promoted to grade II by 22.04.2024 and already received the appointment letters. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application.)

03. Applications

Applications prepared by the candidates as per specimen appended at the end of this circular should be sent under registered cover to reach the Director (Examinations), "Suwasiripaya", No.385, Ven. BaddegamaWimalawansa, There Mawatha, Colombo 10, on or before 22.04.2024 The name of the examination applied for should be mentioned as "Efficiency Bar Examination for School Dental Therapists Grade II - 2024 (First Term)" on the top left corner of the envelope. It is mandatory that the subject officer in charge of the personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination head of division. One self-addressed envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

Note: The application should be prepared using an A4 paper based on the specimen form of application so as to accommodate from 01 to 04 on the first page and from 05 to 09 on the second page. Applications which do not confirm to above will be rejected without any information.

04. Examination fees:-

- i. Candidates who sit the examination for the first time and not need to pay examination fees. However, in every subsequent sitting they should affix stamps to the value of Rs. 25/= per subject in the stamps cage provided for in the application and cancel same by placing their signature and the date.
- ii. The fees once paid will not be refur.Jed or transferred to other examinations under any circumstances

05. Admission to the Examination:-

- i. Candidates, whose applications have been accepted will be issued with admission cards. Candidates should duly complete and submit same to the supervisor at the examination centre. Otherwise the candidates will not be allowed to sit for the examination.
- ii. Candidates should prove their identity to the supervisor at the examination centre. For this purpose one of the following documents will be accepted.
 - (a) National Identity Card
 - (b) A formal identity card issued by the Ministry of Health or a relevant institution.
 - (c) A Valid Driving License

06. Scheme of the Examination:-

This examination consists of two parts viz. Departmental Examination and Efficiency Bar Examination. Departmental Examination consists of Written, Oral and Practical. Each part is given 100 marks and minimum 40 marks should be obtained for each part to pass the examination.

Efficiency Bar examination consist two Papers viz. Establishments Code and Financial Regulations Each part is given 100 marks. Minimum 40 marks should be obtained for each subject to pass the examination.

The examination can be completed in one or several sittings. Applicants who sit for the examination for the first time should apply for all subjects.

07. Syllabus of the Examination

07.1 Subject Related Written

This paper consists of 8 essay type questions and any 05 questions should be answered. Duration is 03 hours. To pass the examination, minimum 40 marks should be obtained. Total marks is 100.
