Third Efficiency Bar Examination for the posts of Control Room Operator, Automobile Technician, Overseer, Electrician and Cinema Machine Operator for which salary scale PL- 03 - 2006 (A) is stipulated of Primary Technical service category of Ministry of Health – 2026 (First Term)

It is hereby notified that the Efficiency Bar Examination which should be passed by officers in the posts of Control Room Operator, Automobile Technician, Overseer, Electrician and Cinema Machine Operator of Primary Technical service category for which salary scale PL – 03 - 2006 (A) is stipulated of Ministry of Health before expiry of 05 years after promoted to Grade I will be held on **31/01/2026** in of Sinhala, Tamil and English medium. The Venue and time of the examination will be mentioned on the admission card.

02. Qualifications

Only the officers who have got an appointment in Grade I in a post (Control Room Operator, Automobile Technician, Overseer, Electrician and Cinema Machine Operator) for which salary scale PL-3-2006 (A) is stipulated of Primary Technical service category of Ministry of Health and those who have not yet completed the examination are eligible to apply for this examination.

N.B:

As mentioned in the General Circular Letter No. 02-90/2015 dated 12.08.2015 of the secretary of the Ministry of Health, Nutrition & Indigenous Medicine, the officers who have exceeded 5 years in the Grade I in the posts of Electrician and Cinema Machine Operator as at 27.07.2012 need not appear for this examination, since such officers are exempted from this efficiency bar examination. (It is mandatory to attach a certified copy of Grade I appointment letter along with the application.)

Take necessary action to send applications of the officers only who have been promoted to Grade I as at **24/12/2025** which is the closing date of applications and have already received the appointment letters.

03. Applications

Applications prepared by the candidates as per specimen appended to this circular should be sent under Registered cover to reach the Director (Examinations) "Suwasiripaya", No.385, Rev. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before **24/12/2025** through their heads of institutions. The name of the examination applied for should be mentioned as **"Third Efficiency Bar Examination of PL – 03 – 2006 (A) of Ministry of Health – 2026 (First Term)"** on the top left corner of the envelope. It is mandatory that the subject officer in charge of the personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. A self-addressed 01 envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without notice.

N.B.:

The Applications should be prepared using an A4 paper based on the Specimen form of Applications so to recommended from 01 to 03 on the First page and from 04 to 08 on the second page. Applications that do not comply with the above format will be rejected without notice.

04. Examination fees:-

- I Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of Rs. 25/- per subject in the stamps cage provided for in the application and cancel same by placing their signature and the date.
- II The fees once paid will not be allowed to transfer for any other examination or refunded for any reason.

05. Admission to the Examination:-

- I Candidates whose applications are accepted will be issued with admission cards. The admission cards should duly completed and submitted same to the Supervisor at the examination centre. Otherwise they will not be allowed to sit the examination.
- II Candidates should prove their identity to the Supervisor at the examination hall. For this purpose one of the following documents will be accepted.
 - (a) National Identity Card
 - (b) A formal Identity Card issued by the Ministry of Health or a relevant institution
 - (c) Valid Driving License
 - (d) Valid Passport

06. Scheme of the Examination:-

This examination consists of an essay type question paper on subject knowledge relevant to the post. Duration is 1½ hours. The question paper consists of 06 questions and 04 questions should be answered. Total marks of 100 will be given. Minimum 40 marks should be obtained to pass the examination.

07. Syllabus of the Examination

Question paper on subject knowledge relevant to the post.

Subject knowledge relevant to the post, subject knowledge on hospital administration and establishment work.

08. To follow the Regulations Related to Examination Procedure


