# Efficiency Bar Examination and Departmental Examination for Medical Laboratory Technologists in Grade II/ Seg.II "A" – 2025

It is hereby notified that the Efficiency Bar Examination and Departmental examination which should be passed before reaching the fourth salary step of the salary scale approved for Medical Laboratory Technologists Grade II/ Seg.II " A " will be held on 23.08.2025 and 24.08.2025 in Sinhala Tamil and English Medium. (The Subject related written question paper will be prepared only in English Medium) The venue and the time of the examination will be notified along with the Admission Card.

#### 02. Qualifications

Only the Officers who have been appointed to a post of Medical Laboratory Technologists in Grade II/ Seg.II " A " and not yet completed this examination are only eligible to apply for this examination.

N.B. Please take necessary action to send me the applications of the officers only who has been promoted to Seg. II "A" / Grade II by 18.07.2025 and already received the appointment letters. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application.)

03. Applications: - Applications prepared by the candidates in compliance with the form of specimen appended to this circular should be sent under registered cover to reach the Director (Examinations) Ministry of Health & Mass Media, "Suwasiripaya" No.385, Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10, on or before 18.07.2025 through their Heads of Institutions. The words "Efficiency Bar Examination and Departmental Examination for Medical Laboratory Technologists in Grade II – 2025" should be mentioned on the top left corner of the envelope. It is mandatory to have certified fact that the candidate had satisfied the qualifications required to sit for the said Efficiency Bar Examination by the officer in-charge of the subject of personal file and that all the particulars furnished in each application are correct by the Head of Institution. And, two (02) self-addressed envelopes (candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs.110.00 should be sent along with the application. Applications received after the closing date, incomplete or inaccurate will be rejected without any notice.

Note: The application should be prepared using an A4 paper based on the specimen form of the application so as to appear the Nos from 01 to 04 on the first front page and from 05 to 09 on the second page. Applications which do not confirm to the above specimen will be rejected without any notice.

#### 04. Examination fees:-

- Candidates who sit the examination for the first time need not pay examination fees. However in every subsequent sitting they should affix stamps to the value of **Rs. 25**/= for each subject in the stamps cage provided for in the application and cancel same by placing their signature and the date.
- II The fees once paid will not be refunded or transferred to other examinations under any circumstances.

#### 05. Admission to the Examination:-

- I Candidates whose applications have been accepted will be issued with Admission Cards. They should submit them to the Supervisor at the Examination center. Otherwise they will not be allowed to sit the examination.
- II Candidates should prove their identity to the Supervisor in the Examination Center. For this purpose one of the following documents will be accepted.
  - (a) National Identity Card

#### 06. Scheme of the Examination:-

This examination consists of two parts viz: Departmental Examination and Efficiency Bar Examination. Departmental examination consists three parts viz: Written, Viva Voce and a Practical and each part are given 100 marks. Minimum 40 marks should be obtained for each part to pass the examination.

Efficiency bar examination consists of two subjects. Establishments Code and Financial Regulations. Each subject is given 100 marks and minimum of 40 marks should be obtained for one subject to pass the examination.

This examination can be completed part by part/subject by subject in one or several sittings. Applicants who sit for the examination for the first time should apply for all subjects.
