Efficiency bar Examination and Departmental Examination for the Officers in Grade II of Audiology Technician' - 2025

It is hereby notified that the Efficiency bar Examination which should be passed by **Audiology Technicians** belonging to the Service of Professions Supplementary to Medicine (MT - 06 - 2016) before expiry of three years from the date of appointment to Grade II will be held on 23.08.2025 and 24.08.2025 in Sinhala, Tamil and English medium. (The Subject related written question paper will be prepared only in English Medium) The venue and the time of the examination will be notified along with the admission card.

02. Qualifications

The officers who have been appointed to a post of Audiology Technician (MT – 06- 2016) in Grade II and not yet completed this examination are only eligible to apply for this examination.

N.B. Please take necessary action to send me the applications of the officers only who has been promoted to Seg. II "A" / Grade II by 18.07.2025 and already received the appointment letters. (It is mandatory to attach a certified copy of Grade II appointment letter along with the application.)

03. Applications

Applications prepared by the candidates as per specimen appended to this letter should be sent under Registered Cover to reach the Director (Examinations), Ministry of Health & Mass Media, "Suwasiripaya", No.385, Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10 on or before 18.07.2025 through their Heads of Institutions. The name of the examination applied for should be mentioned as "Efficiency bar Examination and Departmental Examination for the Officers in Grade II of Audiology Technicians' – 2025" on the top left corner of the envelope. It is mandatory that the subject officer in charge of personal files and the head of the institution certify that all the information provided in each application is correct that the applicant meets the required qualifications to appear for this efficiency bar examination. Two (02) self-addressed envelope (Candidates can write their official or private address) in the size of 9" x 4" inches, affixed with stamps to the value of Rs. 110.00 should be sent along with the application. (Applications received after the closing date, incomplete or inaccurate will be rejected without notice.)

N.B: The application should be prepared using an A4 paper based on the specimen form of application so as to accommodate from 01 to 04 on the first page and from 05 to 09 on the second, page. Applications which do not confirm to above will be rejected without any information.

04. Examination fees

Efficiency bar examination consists of two subjects. Establishments Code and Financial Regulations. Each subject is given 100 marks and minimum of 40 marks should be obtained for one subject to pass the examination.

This examination can be completed part by part/subject by subject in one or several sittings. Applicants who sit for the examination for the first time should apply for all subjects.
