1. The Recommendation list of Annual Transfer of Dental Surgeons 2025 is published herewith after considering the objections forwarded against the “Annual Transfers of Dental Surgeons – 2025 Proposed List (for observations)”. Please consider this as an interim list for calling appeals. Head of the Institutions are advised not to release these officers until the final transfer list is published.
2. This Recommendation list is based on the criteria approved by Public Service Commission in the letter numbered D/DS/AT/234/2025 and dated 30/04/2025.
3. The officers applied for the Annual Transfer of Grade Dental Surgeons 2025 can appeal against the recommendation transfers on or before 14/11/ 2025 stating the reason for appeal.
4. Dental Surgeons are kindly advised to forward appeals only through the online application published on the official website of Ministry of Health and send the printed copy of the same via email to dentalapplicationsonline@gmail.com and also post it to the postal address

5. Annual Transfer proposals review committee will pay due attention to such appeals and the final approved transfers will be ordered after obtaining the approval from Health Services Committee of the Public Service Commission.
6. The word "NOTED NEP" marked against the names of the officers denotes that requested stations were not available at their seniority positions. It is compulsory for them to appeal via the appeal stage of Annual Transfer of Grade Dental Surgeons 2025 for vacant or potentially vacant stations forwarding a fresh list containing an adequate number of preferences. Please note that their original preferences in the initial application will not be taken in to consideration by the Annual Transfer proposals review committee. In a scenario where adequate preferences are not available at their seniority positions even in the appeal stage the respective officers will be allocated a station from the remaining vacancies at the discretion of the Annual Transfer proposals review committee.
7. Officers who have made themselves denoted as Eligible or CNN/Eligible are also free to appeal for vacant or potentially vacant stations as a fresh list of preferences if they wish to get a transfer. Please note that their original preferences will not be taken in to consideration by the Annual Transfer proposals review committee.
8. All Heads of Institutions and Consultant Dental Surgeons should inform any discrepancies in officer allocation to respective stations immediately via the email dentalapplicationsonline@gmail.com.
