Key Instructions:

3. If you have submitted multiple online applications, only the final application will be considered for the placement.
4. Any applicant to an end post (Consultant of each speciality) should have worked as a board certified specialist in the relevant speciality for minimum of 04 years before applying for an end post.

5. Applicants can withdraw their applications until 01/12/2025 if they do not want to proceed with their applications.
6. Applications received from not eligible candidates will be excluded from further processing
