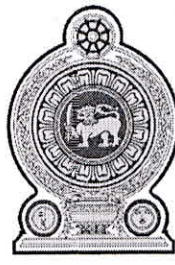

This is further to the earlier communication TCS/M/01/2025 dated 03.07.2025 regarding the transfer of Specialist Medical Officers (after completion of foreign training).

Please note that the Replacement List has been prepared based on the following priority criteria:

1. Replacement for the officers who are on End Post 2025 transfer order but there are no replacement even after Annual Transfer list 2025.
2. Replacement for the officers who are on transfer order by the Annual Transfer 2025 but no replacement for the implementation annual transfer order.
3. Vacant stations where interns are posted but no board certified specialist (main specialties only)
4. To ensure availability of at least one specialist of each specialty per district.
5. To the station where single officer cannot bear the 24 hour service on-service demand.

Heads of Institutions are kindly requested to ensure that salary payments are arranged for officers assigned from this Replacement List.
