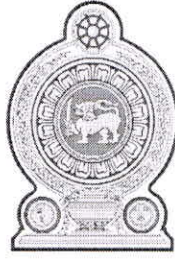

### Annual Transfers of Grade Dental Surgeons 2025 – Special posts - Final list (Pending PSC approval) and calling for the applications for Regular posts (4 year) and remaining special posts

#### 1. Allocation of Special posts

Allocation of special posts in the Annual Transfer of Grade Dental Surgeons 2025 have been finalised and published in the website of Ministry of Health after considering the appeals. Please note that this is not the final transfer order. Final transfer order will be issued following the approval of the Health Service Committee (HSC) of the Public Service Commission (PSC). Until such time, officers are advised not to obtain the release from their respective stations.

#### 2. Applying for 04 year posts and remaining special posts


All the officers are advised to read carefully and comprehend with the contents of this notice before applying for the 04 year posts and remaining special posts of the Annual Transfer of Grade Dental Surgeons - 2025.

Considering the objections received, the amended Final Noted, Eligible, CNN/Eligible list, the amended Final exempted name list from transfers, with amended vacancies, additional vacancies and remaining vacancies after special posts allocation are attached herewith.

- 2.1) All the Noted, Eligible, CNN/Eligible Dental Surgeons whose names do not appear in the Annual Transfers of Grade Dental Surgeons – 2025: Special Posts Final List (Pending PSC Approval) can apply for 04 year posts and remaining special posts, except for the Dental Surgeons who have received Special posts via the initial allocation process of special posts in the Annual Transfer of Grade Dental Surgeons - 2025. Stations of the “Noted” Dental

Surgeons are considered compulsory vacant and Stations of the “Eligible”, “CNN/Eligible” Dental Surgeons may fall vacant if the current incumbent get selected for their preferred post. All the Noted, Eligible and CNN/Eligible Dental Surgeons who are interested in applying for those compulsory vacant and potentially vacant posts may do so.

- 2.2) All the relevant Dental Surgeons should apply only through the published web based online application appearing on the Ministry of Health and Mass Media website on or before **18/08 /2025**. It is hereby informed that the application portal will be opened on 05.08.2025
- 2.3) Applicants are kindly requested to send a hard copy certified by the head of the institution to **“Director -Dental Services, Ministry of Health and Mass Media “Suwasiripaya” 385, Ven. - 2.4) Allocation of the 04 year posts and remaining special posts will be carried out only according to the grade seniority of the Dental Surgeons.
- 2.5) For a Dental Surgeon to apply for a station he/she has previously occupied, the officer has to be away from the particular station for a minimum period of 2 years.
- 2.6) All the Dental Surgeons in the Noted, Eligible, CNN/Eligible list have been allocated a respective merit number. The officers categorized under the “Noted” list are strictly instructed to add preferences up to their respective merit number. Such officers who are not indicating adequate preferences will be categorized as Not Enough Preferences (NEP) and will be assigned a remaining station at the end of the allocation process at the discretion of the Transfer Board.
