They are free to appeal for vacant or potentially vacant stations with a fresh list of preference if they wish to get a transfer. Please note that their original preferences will not be taken in to consideration. Preferences in initial applications will not be considered at appeal stage.

Please note that the HO Ortho vacancy of TH Kaluthara is not available for allocation as it was advertised in 2023 Annual Transfers of Grade Dental Surgeons & SHO Resto vacancy of IOH Maharagama is also not available for allocation as the Officer attached to that station was made CNN as per her request.
