Annual Transfers of Grade Medical Officers – 2026 (Interim List & Invitation to Submit Applications for Review)

The Interim list of Annual Transfers of Grade Medical Officers for 2026 is published herewith. This notice also serves as a calling for submission of a review application. Final transfer orders will be issued after due consideration of the review applications.

Heads of institutions are hereby instructed not to release any Grade Medical Officers based on this interim list.

Please draw your attention to;

1. Review applications are entertained only from Medical Officers whose names appeared in the final noted list for Annual Transfers 2026.
2. Any violations of seniority or errors in the interim order, intimated through the reviews process, will be rectified by the Review Committee on Annual Transfers 2026.
3. If a Medical Officer does not submit a review application, it will be considered that he/she is satisfied with the position allocated in the interim transfer order.
4. All Medical Officers who wish to submit a review must do so, only through the web-based application published on [https:// hrmis.health.gov.lk](https://hrmis.health.gov.lk).
5. The Final List of Transfer Orders will be released after considering all the review applications and with the approval of the Public Service Commission.

6. If insufficient preferences are marked in the review application. The Transfer Board will assign a station at its discretion, and it will be marked as NEP (Not Enough Preferences). Adjustments to seniority due to no-pay leave will be marked as NPL. (No Pay Leave).
7. Please note that this review process is entirely online. And all Medical Officers must submit their review applications on or before **2026/03/12 at 8.00 a.m.** Supporting documents must be uploaded through the provided link. Any claims not mentioned in the special claim box will not be considered by the Review Board.
8. No review applications will be accepted after the deadline.
