## Collecting Information for Annual Transfer of Grade Medical Officers - 2026

The Ministry of Health is in the process of formulating the noted list to be used for Annual Transfers of Grade Medical Officers 2026 from the Medical Officers who are serving in the Ministry of Health, as per the instructions of the letter issued by the Health Service Committee of the Public Service Commission numbered PSC/EST/3/4/1/2013 dated 06<sup>th</sup> November 2023.

The following Medical Officers are to be noted compulsorily for the 2026 Annual Transfer.

- a) Medical Officers who have reported to duty on or before  $31^{\rm st}$ December 2024 as per the Annual Transfer order 2022 or before.
- b) Medical Officers who have reported to duty on or before 31<sup>st</sup> December 2022 as per Special Appeal, North and East, Difficult Station transfers orders.
- c) Medical Officers who reported to duty on or before 31st December 2022 as per Post Intern Assignments.
- d) Medical Officers who are attached temporarily after Foreign Leave, after PGIM studies, or after a Secondment Post for last one year period.
- e) Medical Officers who were reinstated and reported to duty in 2022.

Following Medical Officers can make a request to be noted in for the 2026 Annual Transfer.

- f) Medical Officers who have reported as per Annual Transfer orders of 2023 or 2024 and reported to assigned station on or before 31/12/2024.
- g) Medical Officers who have reported to the assigned station before 31/12/2024 from Special Appeal Transfer orders or North and East/ Difficult Station transfer lists or Post Intern appointment.

Applications for "Requested to be Noted" can be downloaded from <a href="www.hrmis.health.gov.lk">www.hrmis.health.gov.lk</a> and shouldbe submitted to the Head of the Institution to include those names to the noted list through the above link.

Also note that the Medical Officers who are on non implemented transfer (Annual/Special Appeal/North and East and Difficult Station) are not entitled to be noted for the 2026 Annual Transfer List.

The noted list for the Annual Transfers of Grade Medical Officers 2026, will be prepared as an on-line sheet and Heads of the Institutions are requested to login <a href="www.hrmis.health.gov.lk">www.hrmis.health.gov.lk</a> for further instructions in this regard.
