Registration in HRMIS for the Placement List – 2026 Medical Officers who have Completed Local Training (Awaiting Overseas Training)

This is to inform all Medical Officers who have completed their local training (Awaiting Overseas Training) about the mandatory registration for the Placement List 2026.

02. As an eligible applicant for the Placement List 2026, it is essential that you register in the **Human Resources Management Information System (HRMIS)** before 07.08.2026.

03. All eligible Medical Officers who have completed local training (**Associate Specialists**) are required to register in the HRMIS. Please note that only those registered Medical Officers will be considered for the Placement List 2026. Any Medical Officer who fails to register by the deadline will only be considered for remaining vacancies after allocating positions to registered officers. To register in the HRMIS, please use the following link: <https://hrmis-sm.health.gov.lk>. Use your National Identity Card Number as the username when you register in the system.

04. We urge you to complete this registration process at your earliest convenience to avoid any inconvenience.

05. Ensure to fill all relevant data fields accurately and double-check your information. Failure to comply will result in disciplinary action as per the Transfer Board's decision.
