Annual Transfers of Grade Medical Officers – 2026 (Interim List - II & Invitation to Submit Applications for Review)

Please note that the Annual Transfer Interim List 2026, published on 2026-02-27, is hereby cancelled. The Interim List II of Annual Transfers of Grade Medical Officers for 2026 is published herewith. This notice shall also serve as a call for submission of review applications. Final transfer orders will be issued after due consideration of the review applications.

Heads of institutions are hereby instructed not to release any Grade Medical Officers based on this interim list.

Please draw your attention to the following:

1. Those who have already submitted review applications will be required to resubmit their applications if they wish to do so.
2. Review applications will be entertained only from Medical Officers whose names appeared in the final noted list for Annual Transfers 2026.
3. Any violations of seniority or errors in the interim order, brought to notice through the review process, will be rectified by the Review Committee on Annual Transfers 2026.
4. If a Medical Officer does not submit a review application, it will be considered that he/she is satisfied with the position allocated in the interim transfer order.
5. All Medical Officers who wish to submit a review application must do so only through the web-based application published on <https://hrmis.health.gov.lk>.

6. The Final List of Transfer Orders will be released after considering all review applications and with the approval of the Public Service Commission.
7. If the request made in the review application cannot be accommodated, the station assigned in the interim list will remain unchanged.
8. Please note that this review process is conducted entirely online. All Medical Officers must submit their review applications on or before 2026-05-18 at 8.00 a.m. supporting documents must be uploaded through the provided link. Any claims not mentioned in the special claim box will not be considered by the Review Board.
9. No review applications will be accepted after the deadline.
