Mandatory Registration: HRMIS Specialist Module (Replacement List – 2026)

This is to officially inform all eligible **Acting Specialists** who have completed overseas training and reported to the Ministry of Health (with or without PGIM Board Certification) to register for the **Replacement List 2026**.

- **Portal Link:** <https://hrmis-sm.health.gov.lk/login>
- **Deadline:** On or before **14th June 2026**

1. Eligibility Criteria

You must register if you have returned from overseas training, reported to the Ministry, and meet **both** of the following:

- Not eligible for Annual Transfers 2026 due to any reason.
- With or Without PGIM Board Certification (including those Board Certified *after* 31st December 2025).

2. Action Required & Category Selection

Log in to the portal, update your "**Current Station**," and select your correct **Appointment Status**:

Category A: After Foreign Training – WITH PGIM Board Certification

- **Action:** Upload your PGIM Board Certification letter (issued before the deadline).
- **Data entry:** Enter the 'Specialist Grade Effective Date' exactly as stated in the letter ("*With effect from...*").

Category B: After Foreign Training – WITHOUT PGIM Board Certification

- **Action:** Mandatory registration for all Acting Consultants who reported back on or before the closing date.
- **Important Note:** Failure to apply will result in placement under **Transfer Board Discretion**.

Existing registered users must review, verify, and correct their profiles before the deadline.


3. Data Accuracy & Seniority

The seniority marking system is **fully automated** based on the two categories above. Providing false or misleading data is a serious violation and will lead to disciplinary action.
