### **Annual Transfers 2026 – Corrected Provisional Noted List after considering the individual responses of Grade Dental Surgeons for the name list published on 10th February 2026**

The Corrected Provisional Noted List, prepared after considering the individual responses submitted by Grade Dental Surgeons in relation to the Provisional Noted List published on 10 February 2026 for the Annual Transfers – 2026, is attached herewith as Annexure 01.

Please note that eligibility for inclusion in the Annual Transfer process has been determined based on the closing date of 31.12.2025.

### **1. Criteria for Selection to the Corrected Provisional Noted List – 2026**

1.1 Dental Surgeons who were assigned to posts through the Annual Transfer process and who had completed four (04) years or more at their present station as at 31.12.2025, calculated from the effective date of the transfer order.

1.2 Dental Surgeons who were assigned to Special Posts through the Annual Transfer process and who had completed two (02) years or more at their present station as at 31.12.2025, calculated from the effective date of the transfer order.

1.3 Newly appointed Dental Surgeons who had completed four (04) years or more at their present station as at 31.12.2025, calculated from the effective date of the appointment letter.

1.4 Newly appointed Dental Surgeons assigned to Special Posts who had completed two (02) years or more at their present station as at 31.12.2025, calculated from the effective date of the appointment letter.

1.5 Dental Surgeons serving on temporary attachment following foreign leave, PGIM studies, or secondment appointments as at 31.12.2025.

1.6 Officers who remained at the same station without reporting to the station specified in a previous transfer order have not been included in this list.

1.7 Dental Surgeons assigned to two-year posts through the 2024 Annual Transfers and those assigned to one-year posts through the 2025 Annual Transfers have not been included in the 2026 Annual Transfer process, as they had not completed the required period of service by the closing date of 31.12.2025.

1.8 Dental Surgeons who received a Special Post under the 2024 Annual Transfer or a one-year post under the 2025 Annual Transfer and who requested inclusion in the Provisional Noted List through the online application process have been considered in accordance with the applicable transfer policy.

## **2. Criteria for Inclusion in the Eligible List and for Being Considered as Eligible (Not Noted)**

2.1 All requests for inclusion in the Eligible List (to remain at the present station or to apply for a desired post), and any other claims submitted through the prescribed web-based application have been considered in preparation of this list.

2.2 All Dental Surgeons who come across any error or omission are kindly requested to submit their notifications only through the official online application portal published in this notice.

2.3 Requests submitted after 25th June, 2026 won't be considered for the final noted list which will be published soon after the closing date.

2.4 Officers who had completed two (02) years or more at their present station as at 31.12.2025, based on the effective date of the transfer order, were eligible to apply for the Annual Transfers – 2026.

2.5 Officers becoming eligible upon request were considered for transfer according to their stated preferences. Where no suitable preference was available, they may be permitted to remain at their current station.

2.6 Where an eligible officer has been assigned a station included in his or her preferences, no appeal to remain at the present station will be entertained after publication of the recommendation list.

2.7 All applicants are responsible for ensuring the accuracy of the information submitted. The Transfer Board shall not be responsible for any inconvenience arising from inaccurate or misleading information.

## **3. Mandatory Submission**

It is mandatory for all Grade Dental Surgeons belonging to the categories specified in Paragraphs 1.1 to 1.8 to have provided the required information, even if their names did not appear Corrected Provisional Noted List, prepared after considering the individual responses submitted by Grade Dental Surgeons in relation to the Provisional Noted List published on 10 February 2026 for the Annual Transfers – 2026 (Annexure 1)

#### 4. General Note

The names appearing in the Corrected Provisional Noted List are not arranged in order of merit. The criteria and procedures governing the Annual Transfer Process – 2026 will be communicated in the covering letter accompanying the Final Noted List.
