Amendments to the Placement List – 2026 (Acting Consultants Awaiting Overseas Training) – Amendment 11

Further to my letter No. TCS/E/PL/SR/2026 dated 09.09.2026, the amended list (11) of vacancies/stations by specialty for the Placement List – 2026 is hereby issued.

Due to service exigencies, certain vacancies/stations have been added to, while some vacancies/stations have been removed from, the list previously published on 09.09.2026.

Accordingly, all eligible applicants are hereby instructed to comply with the following:

1. The online application system is available at: <https://hrmis-sm.health.gov.lk>
2. Applicants who have already submitted their applications may use the “Reset” option to reset their previous entries and resubmit their applications based on the amended list of vacancies/stations. **The deadline for the submission of applications has been extended until 17.09.2026 to facilitate this process.**
3. Applicants belonging to specialties/subspecialties for which no amendments have been made to the vacancy/station list are not required to resubmit their applications, provided that they have already submitted their applications.

4. All eligible officers are required to submit their applications indicating their preferred stations in accordance with the prescribed procedure. Officers who fail to submit an application indicating their choices within the stipulated period will be considered for placement at stations determined at the discretion of the Transfer Board.
5. If an eligible applicant encounters any difficulty or technical issue in applying for the relevant specialty/subspecialty or in selecting the available stations, it is the responsibility of the applicant to notify the Director (Tertiary Care Services) immediately.
